



UNPACKING INSTRUCTIONS



The Permafil Filter is completely assembled in its shipping carton. It may be necessary to partially disassemble it during unpacking. After reassembly, the unit is ready for use.

The filter has 4 major components:

- 1. Tank
- 2. Filter screen and suction pipe assembly
- Pump, motor and piping assembly
- 4. Hose assembly

Item 3 hangs on the rear edge of item 1.


Items 2 and 4 attach to item 3 with quick connect fittings.

UNPACKING AND ASSEMBLY

- 1. Remove packing material and remove filter from shipping carton.
- Remove item 3 from tank by breaking quick connect fitting from item 2. Check piping and fittings for damage in shipment. If damage is noted, contact UPS and Filter-All immediately.
- 3. Remove item 2 from tank. Observe screen and tank for dirt or debris, clean if necessary.
- 4. Replace filter in tank.
- 5. Hang item 3 on tank and make up fitting on screen assembly. Unit is ready for service.


OPERATING INSTRUCTIONS

CAUTION: The equipment and cooking oil are at high temperatures. Do not touch any metal surfaces. Protective aprons, gloves and face shields should be worn at all times.

- 1. Position filter tank under drain valve of the fryer. Cooking oil temperature should be 325 350 F
- 2. Pour 12oz. of Permafil Filter Powder into cooking oil in the fryer and stir until it is evenly distributed.
- 3. Make sure the fryer is turned off.
- 4. Drain cooking oil into the filter tank. Use caution to avoid splashing.
- 5. Position hose over fryer. Turn on filter pump and wash debris from the bottom of the fryer into the filter tank. Turn pump off and insert hose nozzle into the square circulating hole in the filter tank.
- 6. Turn on filter pump, and circulate for 5 to 7 minutes or until the oil is clear. Turn pump off.
- 7. Close fryer drain valve. Position hose over the fryer.
- 8. Turn on filter pump and pump the oil from the filter into the fryer. Stop the pump when the oil level in the filter tank is below the top of the filter screen.
- 9. Proceed to the next fryer and repeat except omit step 2.
- 10. After oil in all the fryers have been treated, allow filter to cool, and commence cleaning procedures. See page 5.

CLEANING PROCEDURE

CAUTION: Equipment may be hot. Do not touch metal surfaces. Protective aprons, gloves and face shield should be worn.



Note: If some water remains in the filter when it is put in service, it will boil out when hot cooking oil is treated. This will not hurt the oil, but may result in splattering oil. Caution must be observed.

Do not run water through pump.

MAINTENANCE SCHEDULE

1. DAILY


- a. While filter is in service, observe piping and fittings for leaks. Do not attempt to correct while the pump is running.
- b. After cooking oil treatment for the day is completed, clean filter screen and tank with hot water. See page 5 for cleaning procedures.
- c. Wipe oil from pump and motor enclosure, and other parts.

NOTE: Do not use soap. Do not run water through the pump.

2. WEEKLY

- a. Disassemble filter screen and wash with hot water.
- b. Inspect discharge hose for cracks. Cracks will appear before the hose starts to leak. However, the hose should be replaced when the cracks appear.




- 1. The sales receipt or other evidence of the date and place of purchase.
